

Abstracted Summary of Final Actions: January-February 2025

Northwest Nazarene Divinity School - Nampa, ID

To acknowledge notification of an institutional name change *from* Northwest Nazarene University Graduate School of Theology *to* Northwest Nazarene Divinity School, and affirm that this does not represent a substantive change, as specified in *Policies and Procedures*, IV.C.1.2.

ACTION TAKEN RELATED TO MONITORING

Interdenominational Theological Center - Atlanta, GA

To require a teach-out plan by the 1st of April 2025, since the FY 2023 audit names a "going concern" (see Policies and Procedures, III.L.1)..

ACTION TAKEN RELATED TO PUBLIC SANCTION (WARNING, PROBATION, OR SHOW CAUSE)

Interdenominational Theological Center - Atlanta, GA

To issue the following warning because the school, while substantially meeting the Commission *Standards of Accreditation* as a whole, is at risk of not meeting the following specific Standards. The school must address this warning adequately and immediately, or the Board will take appropriate action as described in the *Policies and Procedures*, III.G-J. [Effective February 21, 2025, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective Date of Accreditation Decisions); cf. VII.A.4-5 and VIII.A.1-3]

Standards 10.3 and 10.7 on Financial Resources. The school is at risk of not having "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." Additionally, the Board authorizes a focused evaluation visit in spring 2025 to assess the school's financial viability and sustainability in light of this warning. If the school is unable to demonstrate financial viability and sustainability, it will be necessary for the Board to impose probation or issue show cause.

Loyola University Chicago Institute of Pastoral Studies - Chicago, IL

To issue the following warning because the school, while substantially meeting the Commission *Standards of Accreditation* as a whole, is at risk of not meeting the following specific Standards. The school has two years to address this warning adequately, or the Board will take appropriate action as described in the *Policies and Procedures*, III.G-J, which usually means imposing probation. [Effective February 21, 2025, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective Date of Accreditation Decisions); cf. VII.A.4-5 and VIII.A.1-3]

Standards 2.6-7 on Educational Evaluation: While progress has been made in identifying artifacts and developing rubrics, the school has an insufficient evaluation process for its educational programs. A structured gathering of data along with a sustained process of analyzing and reflecting upon that data is largely absent. Because of this, data are not available to inform possible educational improvement ("closing the loop"). The school must include in its self-study, in preparation for a comprehensive visit in the spring 2026, clear documentation of how it meets all four parts of Standard 2.6 for each degree (especially parts b, c, and d) with an educational evaluation plan that addresses the items listed in Standard 2.7, including "clear benchmarks for evaluating success." The school is encouraged to consult the Board's <u>A Reflective Guide to Effective Evaluation for Theological Schools</u>.

Saint John's Seminary (MA) - Brighton, MA

To issue the following warning because the school, while substantially meeting the Commission *Standards of Accreditation* as a whole, is at risk of not meeting the following specific Standard. The school has two years to address this warning adequately, or the Board will take other appropriate action as described in the *Policies and Procedures*, III.G-J. [Effective February 21, 2025, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective Date of Accreditation Decisions); cf. VII.A.4-5 and VIII.A.1-3]

Standard 10.3 on Financial Resources. The school is at risk of not having "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The school must submit a report by the 1st of November 2026, documenting progress toward financial sustainability, including a financial plan that is "realistic, holistic, and sustainable." The school's most recent audit, along with any management letter, must be appended to the report.

Starr King School for the Ministry - Oakland, CA

To issue the following warning because the school, while substantially meeting the Commission *Standards of Accreditation* as a whole, is at risk of not meeting the following specific Standard. The school has two years to address this warning adequately, or the Board will take other appropriate action as described in the *Policies and Procedures*, III.G-J. [Effective February 21, 2025, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective Date of Accreditation Decisions); cf. VII.A.4-5 and VIII.A.1-3]

Standard 10.3 on Financial Resources: While the school has taken steps to shift its financial model and eliminate budget deficits, it remains at risk of not having "sufficient and stable revenue streams and financial resources to achieve its mission with educational quality and financial sustainability." It must submit a report by the 1st of November 2027, regarding operating results that demonstrate a trajectory toward a consistent pattern of surpluses over time. The report should include the school's plans for ensuring sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability, the FY 2026 and 2027 audits and management letters (if available), the school's analysis of its FY 2028 operating revenues and expenditures, and budget projections for two to three years.
